**The Centerville Gas Department will provide the first 100 feet of service line. Any additional service line will be charged to the customer at \$2.00 per foot.**

The Centerville Gas Department does not maintain any customer buried piping located downstream of the outlet end of the customer's gas meter. If you have any buried piping downstream of your gas meter, you are required to maintain the buried piping. Buried piping is subject to potential hazards such as corrosion and/or leakage. You, the customer, should periodically inspect your buried piping for leaks. If your buried piping is metallic, you should periodically inspect for leaks and corrosion. The customer is responsible for repairing any unsafe condition that may exist. All excavating near buried gas piping should be done by hand ( no mechanical equipment such as backhoe or trencher ). The buried piping should be located in advance to any excavating. Plumbers and/or heating contractors can assist you in locating, inspecting, and repairing your customer owned buried piping.

The City of Centerville Gas Company is offering all new customers and those customers who need replaced service lines an excess flow valve meeting industry standards. This valve will be installed in order for the City of Centerville Gas Company to provide a safer means of transporting natural gas. In the unfortunate event your natural gas service line were to be damaged from digging, third party damage, or natural disasters, the presence of this device would insure that natural gas flow would automatically shut off if the service line breaks. The installation of the valve would require the customer to bare all cost, including maintenance and replacement, if necessary. Currently, the City of Centerville Gas Company is requiring the customer to pay the cost of the valve at their cost. This cost would be above any cost normally charged to the customer for a new service line. If the excess flow valve requires additional maintenance for resetting after a trip, then the cost would be \$100.00 per occurrence. As a reminder, all excavating near buried gas piping should be done by hand ( no mechanical equipment such as backhoe or trencher ). The buried piping should be located in advance to any excavating.

## GAS SYSTEM AGREES TO:

Operate and maintain the gas system so as to provide gas to users in a business like and adequate manner.

## MUTUAL AGREEMENTS:

The applicant will be responsible for marking a location for the tap. The Town of Centerville reserves the right to move a tap in the event of rock or other problems associated with the tap. The Town of Centerville is granted the right of ingress and egress necessary for successful operation and maintaining its natural gas lines and appurtenances. The natural gas meter shall remain the property of the Town of Centerville. The tap fee shall be non-refundable. The deposit will be held by the Town for payment of the accounts should service be terminated for any reason and the account remain unpaid. Applicant agrees to pay bill in full when due, and understands that in the event of his/her failure to pay the Town of Centerville shall have lawful right to collect the bill with an extra charge and/or disconnect service. The applicant will notify the Town of Centerville should they move from this location and furnish a correct forwarding address for final billing.
